## 21. Minutes of the last Meeting

# 22. Matters arising

Having examined the rules it was determined that the executive committee consists of the officers, the national councillor, representatives appointed by each local league and co-opted members that the officers determine have a specific role. Consequently it was determined that the rules do not give rise to appoint the President on to the committee. However it was decided that the Secretary should continue to send a copy of the Minutes to the President as a matter of courtesy.

# 24. Treasurer's report

## Income

Since the last meeting we have received Affiliation fees from Kidderminster, Malvern, Worcester and Dudley. Nothing yet from Bromsgrove & Redditch or Evesham.

Dudley have paid a £20 fine for not sending a representative to the first Committee meeting.

We received £4.25 from TTE which was for pooled expenses from County Championships held in Birmingham. We then received an invoice from TTE for £4.25 for County Championship pooled expenses. It turned out that they should not have paid us, we should have paid them so Martin has paid £8.50 to TTE.

#### **Expenditure**

We have paid out £115 for Worcester Schools' affiliation to ESTTA. We paid £21 to Dudley for reimbursement of juniors' Affiliation fees.

Kidderminster claimed for last year's juniors and also for this year's juniors. Martin paid £104 to Andrea Holmes for 2 years juniors. Cadets played last November/Dec in County Championships so we paid £94.03 for last years pooled expenses.

There was a discussion regarding the refund of junior and cadet's Affiliation fees. Martin does not think refunding fees encourages players to join the league.

Richard Cullis suggested we pay the first year for them to enter the league. Martin would like to see something like paying for coaching sessions for juniors and cadets. It would be up to the leagues to organise this themselves maybe one visit per annum by Helen Lower. Bernie Leech suggested reducing entry fees for juniors County Closed. John Stalker thinks we should have different incentives to give to juniors. John Stalker said we need coaches willing to go into Schools.

#### **25.** National Council - Martin Clark

The last National Council was held on 29<sup>th</sup> September at Newport Pagnell

Chris Dangerfield became the new Chairman of National Council by election. The layout was changed to sitting in a semicircle. Some of the Board were present. The meeting was split into 2 parts, a morning and an afternoon session. The morning session was spent looking at the reports from the Board. Two new steering groups have been set up. One called MAG and the other Voting reviews.

The issue of financial reporting was a source of negative debate. A statement was read out based on the panels' recommendations. National Council has no need to see the reports. A speech was given by Pete Charters on performance and talent development.

It was suggested that the next meeting be on 24<sup>th</sup> November but the Board have rejected this as they are not prepared to pay for a meeting in November.

It was decided that National Council set up a sub group to make financial reporting recommendations to the Board. This would be Martin Clark, Neil Hurford plus one other. Martin thinks that the Boards' view is that National Council has no place anymore.

#### **26.** Cadet and Junior rankings - Bernie Leech for Nigel Anson

Nigel Anson is definitely going to keep running cadet and junior teams. He had trials in September. Cadets played first day on 20<sup>th</sup> October. The second day is 15<sup>th</sup> December. Juniors 1<sup>st</sup> day is 3<sup>rd</sup> November and second day is 6<sup>th</sup> April. He is prepared to keep all teams going. John Stalker has been asked to be Umpire on 3<sup>rd</sup> November at Draycot.
