# **RULES**

#### TITLE

1. The League shall be called the 'Harlow Table Tennis League' hereinafter called 'The League'.

#### **OBJECTS**

2. Its objects shall be to arrange and conduct inter-club and individual championship competitions between affiliated clubs and members and to promote the game of Table Tennis in every possible way.

#### CONSTITUTION

Acceptance of clubs into the League shall be at the discretion of the Executive Committee.
 Each club affiliated to the League shall also be affiliated to

the ECTTA and Table Tennis England, whose rules and regulations shall be observed.

# **AFFILIATION FEES**

5. There will be an affiliation fee per team. The fee for a team will be reduced if the team is all junior. All fee amounts will be proposed by the Executive Committee and presented to a General Meeting Otherwise they will remain the same as in the previous season. The fees shall include all affiliation fees and the entrance fees to all competitions run by the League during a season and automatically cover a player against any claim for injury under the third-party insurance scheme. 6. The fees shall be paid to the Hon. Treasurer before the first of October each year.

(There is no player fee to league but to Table Tennis England. To pay online go to www.tabletennisengland.co.uk then click on Membership and Register or Renew. Or use Search box to find Alternative Ways To Purchase Membership for a form to post. Or call 01908 208898 to do on phone. Senior is £16, or Junior £8, to be paid before playing in any league matches.)

#### **OFFICERS**

7. The honorary officers of the League shall be: President, Chairman, Vice-Chairman, General Secretary, Treasurer, Match Secretary, Results Secretary, ECTTA Representative, Press Officer, Development Officer, Tournament Secretary, Welfare Officer, four Committee members and a Coaching Officer.

#### **ADMINISTRATION**

8. The management of the League shall be the concern of the Executive Committee, hereinafter called "The Committee" which shall consist of Chairman, Vice-Chairman, General Secretary, Treasurer, Match Secretary, Results Secretary, Press Officer, Development Officer, ECTTA Representative, Tournament Secretary, Welfare Officer, Coaching Officer and four Committee members.

9. Fifty percent of the members of the Committee shall form a Quorum. The Chairman shall only have the casting vote.10. The above officers shall be elected at the AGM of the League, with the exception of a Minutes Secretary, who may be nominated by the Executive Committee.

The Committee shall control the League activities and shall have the power to make all decisions between League General Meetings, and in special circumstances, to be decided by the majority of the Committee in Meeting, may disregard the impositions of Rules 24, 25a and 25b, co-opt to fill vacancies and request resignation of any members who fail to attend three consecutive meetings without satisfactory explanation.
 (a) The Chairman, Vice-Chairman and General Secretary shall

form a Standing Committee and shall be responsible for any decision taken between Committee Meetings, but they shall not overrule any decision taken by the Executive Committee.

#### **ADMINISTRATION (continued)**

(b) The Committee shall decide which three out of the following four: Chairman, Vice-Chairman, General Secretary, Treasurer, shall be signatories at the bank. Two out of all three signatories must appear on all cheques.(c) During the playing season the Committee shall meet at least six times, seven days notice to be given of any such meetings.

(d) The property of the League shall be vested in the Committee.

#### ANNUAL GENERAL MEETING

12. Club secretaries shall be given 28 days notice of the AGM to be held in May or June each year. Each club (which must be represented, see Rule 37) may send any number of its members, but only one delegate per team may vote. Decisions on all matters, other than those relating to the Rules, shall be taken by a simple majority vote. In the case of Rule changes, a two-thirds majority is required. The AGM shall have the power to appoint Vice-Presidents of the League.

### **ALTERATIONS TO RULES**

13. Alterations and/or additions to these Rules can only be made at the AGM or at an EGM especially convened for that purpose. In the case of the AGM any proposal must be submitted in writing to the General Secretary 21 days before the AGM. Proposals can be made by the Committee or an affiliated team after such proposals have been approved by a majority of the registered members of that team.

### SPECIAL GENERAL MEETING

14. An Extraordinary General Meeting may be convened by the Committee or, upon receipt by the General Secretary of a written application signed by a minimum of half the affiliated clubs, such a Meeting to be held within 21 days of receipt of such an application. No other business shall be discussed other than that for which the Meeting was convened. At least 14 days notice of an EGM shall be given to the Club Secretaries. All registered members shall be entitled to vote except in the case of Rule changes.

#### DIVISIONS

15. The League shall by divided into divisions according to the number of teams affiliated. The Committee shall have the power to refuse application of any Club they consider unsuitable, the reason for such a refusal to be given in writing.

16. The team coming top of each lower division shall be promoted and the team coming second shall be entitled to be promoted. The balance of the division shall be maintained by relegation of bottom teams.

17. Vacancies caused by withdrawals at the end of the season shall be filled at the discretion of the Committee or by promotion from lower divisions. Should any team withdraw from the League during a playing season its record shall be deleted.18. Positions in the League divisions shall be decided on points obtained. In the case of a tie the position shall be decided on played games average, except when promotion or relegation is involved when the Committee shall arrange a play-off.19. A new Club may apply to enter any division, or a club may

apply to enter a fresh team in any division, but their acceptance and placing shall rest entirely with the Committee.

# **REGISTRATION OF PLAYERS**

20. Only players <u>paid-up to Table Tennis England</u> and registered in writing with the Results Secretary shall be eligible to play in League matches and Closed Championships organised by the League in any one season. There shall be no limit to the number of players registered to any one Club, but only bona fide members of Clubs can be registered. Players shall not be registered for more than one Club at any time. The Committee shall have the power to refuse registration of any players they consider unsuitable or who stand in debt to a previous Club.

21. Each team is not more than six registered players except at the discretion of the Committee. At least three named players per team must be registered on application; additional players must be registered (see Rule 20) at least 48 hours before playing a match. This shall apply to players of all clubs except those covered by Rule 22(a). Should a player change his Club, the Secretary of his new Club must inform the Results Secretary of the transfer, in writing, at least 48 hours before any match is involved. A player may make such transfer in a season. No new registrations for the season will be accepted after the 31st December except at the discretion of the Committee.

22. A player can be registered by one Club and play for one team only except as provided below:

(a) In Clubs having two or more teams a player may play for a higher ranking team than the one for which he was registered. If he/she plays more than three matches in higher divisions he/she must have his/her playing position reviewed by the Committee, in consultation with the player's Club Secretary. In the event of a Club having two teams in the same division, no player can play for more than one team in that division.

b) Clubs having two or more teams may not transfer a player to a lower ranking team than the one for which he was originally registered except at the discretion of the Committee.

(c) Where a Club has more than one team in the League the teams may consist of any three or more players, their League placing to be decided by the Management Committee on known results and/or playing abilities.

#### **REGISTRATION OF PLAYERS (continued)**

23. Entries for the Individual Closed Championships will only be accepted if the players have taken part in 25 per cent of all League matches played since the date of registration, with a minimum of four, except for seeded players for all events who must have taken part in 50 per cent of all League matches played since the date of registration. This may be waived for Junior events at the Committee's discretion.

# **LEAGUE FIXTURES**

24. League fixtures shall be arranged by the Committee and Clubs shall notify their available evenings, preferably avoiding Fridays, for respective team matches to the General Secretary. The fixtures shall be published at least two weeks before the first match is to be played. A fine of  $\pounds 1.00$  may be imposed on any Club whose team fails to turn up and the 10 points may be awarded to the non-offending team.

25. (a) If a match cannot be played on the home team's match night, it may be postponed. The Results Secretary must be informed in writing by both teams within 14 days as to when the game is by mutual agreement to be played. In the event the match is not played, no points shall be awarded to the defaulting team. The other team, at the end of the season, shall be awarded the average number of points scored by that team in all league matches played by them during the season, or the same number of points as scored against the defaulting team in the other half of the season, or six points, whichever is the greatest.

25. (b) Teams changing their home match night must notify all opposing teams, giving at least 7 days and no more than 21 days notice for each home fixture. The Results Secretary must also be notified immediately.

26. (See Rule 4). Playing conditions may be subject to inspection by officers delegated by the Committee.

# **LEAGUE FIXTURES (continued)**

27. Teams competing in any League match shall consist of three players only. The home team captain shall present the opposing team captain with a Result Card with his half filled in; the opposing team captain will then fill his part in before the match commences, except as provided in Rule 31. The doubles pair can be decided after the ninth tie.

28. For the purpose of the Order of Play the home team shall be known as A, B, C, and the opposing team as X, Y, Z. There will be a total of ten ties:

The Order of Play to be as stated except in exceptional circumstances, when the order can be altered only by the mutual consent of both team captains. The match must be played to finish. 29. The team shall be awarded one point for each tie won. 30. The result card, properly filled in and signed by both captains, shall be forwarded to the Results Secretary by the Home team captain within three days or his Club shall be subject to a fine of 50p in the first instance, and £1.00 for any subsequent occasion. 31. Unless arranged earlier, matches must begin at 7.45 pm. No match can commence unless at least two members of each team are present. If a team shall be short of a player half an hour after the agreed time for starting a match, this player's points will be awarded to their opponents, except by mutual agreement of both captains concerned. In the case of a team turning up more than three times with only two players, on the fourth and subsequent times three points will be deducted from their total.

32. Protests regarding any match must be made by the protesting team's Club Secretary within 7 days of the date of the match. A copy of the protest must be sent to the General Secretary and the Club Secretary whose team the protest concerns. The Results Secretary will ask for the latter's written comments on the protest and will withhold the points from the records pending an enquiry by the Committee, at which a representative from both Clubs involved may be granted a personal hearing. No points shall be awarded without the approval of the Committee.

# **GENERAL PURPOSE**

33. No payment can be made or award given to any players for participating in any event undertaken by the League other than prizes as provided for in the Rules of Table Tennis England.

34. Selection of representative teams and team captains shall be the responsibility of the Executive Committee.

# **BREACH OF RULES**

35. The Committee shall have the power to warn or fine any Club (or player) guilty of a breach of the Rules.

36. In the case of flagrant disregard of the Rules, the

offending Club (or player) may be expelled from the League for that season.

37. All Clubs will be fined  $\pounds 1.00$  for each team not represented at the AGM by at least one member.

38. The Executive Committee shall have the power to deal with all matters not covered by these Rules, and any Club (or player) not accepting them will be interpreted as having broken Rule 36.

# TROPHIES

39. All Clubs will be held responsible for any League trophies awarded to their members and in the event of damage or loss must repair or replace them.

# DISSOLUTION

40. Dissolution shall be by a General Meeting called and conducted in accordance with Rules 12 and 14 with dissolution and method of distribution of net assets on the agenda.

### NORTON CHALLENGE CUP Conditions and Rules of Play

 Teams shall consist of three players, and preferably one reserve, who shall be registered with the Results Secretary.
 Extra players can be registered with the Results Secretary after the commencement of the competition, but such registrations must be made at least 24 hours before the start of a match in which a newly-registered player is to play.
 Only teams which have played with a complete team of three players in the first round will be eligible to play in the Consolation Cup Competition. At the Committee's discretion, a team winning the first round by default or against a team with two players may be offered the choice of continuing in the Norton Cup or entering the Consolation Cup Competition.
 Unless matches are nine singles, players including the reserve(s), may be required to be registered in order of merit and this ranking order be kept in all matches.

5. The format will be decided by the Executive Committee.

6. All matches to be played in accordance with ETTA Rules.

7. Results to be sent to the Competition Organiser within 48 hours of the match being played.

8. All rounds preceding the final should be completed within the weeks allocated to them on the League Fixture Chart. The final will be played on a date and at a venue arranged by the Competition Organiser.

9. With the exception of the teams disqualified under Rules 3 or 4 above, teams defeated in Round 1 will be eligible to compete in the Consolation Cup Competition.

10. Only players who have played in at least 25 percent of all league games up until the date of the match may appear in the second and subsequent rounds, except at the discretion of the Committee.

11. The Executive Committee shall have the final decision on all points not covered by the above Conditions and Rules.

#### THE SERVICE LAW

#### 2.6 The Service

2.6.1. Service shall start with the ball resting freely on the open palm of the server's stationary free hand.

2.6.2. The server shall then project the ball near vertically upwards, without imparting spin, so that it rises at least 16cm after leaving the palm of the free hand and then falls without touching anything before being struck.

2.6.3. As the ball is falling, the server shall strike it so that it touches first his court and then, after passing over or around the net assembly, touches directly the receiver's court; in doubles, the ball shall touch successively the right half court of server and receiver.

2.6.4. From the start of service until it is struck, the ball shall be above the level of the playing surface and behind the server's end line, and it shall not be hidden from the receiver by the server or his doubles partner or by anything they wear or carry.

2.6.5. As soon as the ball has been projected, the server's free arm and hand shall be removed from the space between the ball and the net. The space between the ball and the net is defined by the ball, the net and its indefinite upward extension.

2.6.6. It is the responsibility of the player to serve so that the umpire or the assistant umpire can be satisfied that he complies with the requirements of the Laws, and either may decide that a service is incorrect.

2.6.6.1. If either the umpire or the assistant umpire is doubtful of the legality of a service he may, on the first occasion in a match, interrupt play and warn the server; but any subsequent service by that player or his doubles partner which is not clearly legal shall be considered incorrect.

2.6.7. Exceptionally, the umpire may relax the requirements for a correct service where he is satisfied that compliance is prevented by physical disability.

#### CHANGES IN RECENT YEARS TO OTHER LAWS

- Racket coverings must be on the ITTF approved list.
- Racket must not be changed while playing opponent.
- A double hit does not lose point if it was accidental.
- Expedite cannot be called now at score of 10-8 also.

#### MATCH BALLS

Match balls are as provided by the home team. Under the Approved Laws of Table Tennis the ball shall be of a brand and type currently approved by the ITTF. They include both celluloid and poly plastic balls, and so either can be used, so long as it is one from the ITTF list of approved brands.

Once all team entries and any details were received, the Committee first evaluated the effects of applying normal promotion rights and relegation, together with requested team preferences and relative team strengths. The latter resulted in five teams in Premier, ten in First and nine in Second divisions. Clearly this was not workable because - <u>it is absolutely essential that all divisions have the same fixture programme using the same chart, and based on an even number of teams</u> regardless of the <u>actual number of</u> <u>teams</u> in each division.

After long discussions <u>of all options</u> it was clear that with 24 teams, the previous preference for three divisions each of eight teams playing each other three times would not be viable or acceptable. For example, there are not three other teams strong enough, or willing, to compete three times with each of the five clearly Premier teams.

The Committee decided that the only viable option for this year is four divisions, each with six teams playing each other four times - twenty matches in twenty league match weeks. In order to vary the divisions a little, the twenty league weeks are broken up into two separate competitions of ten matches each (ie a full set of home and away fixtures each). And after the first half, the top teams of divisions 1A, 1B and 2 will be promoted, and the bottom teams of the Premier, 1A and 1B divisions relegated. Postponed matches <u>must</u> be caught up quickly so that details of the second competition can be advised by the time it is due to begin on 14 January.

This whole arrangement will be re-evaluated by league Committee next year and discussed at the AGM.


