NORTHUMBERLAND TABLE TENNIS ASSOCIATION TEAM HANDICAP KNOCKOUT CUP COMPETITION REGULATIONS FOR SEASON 2019/2020

- (1) Entry to the competition is open to all teams contesting in the Northumbria League 2019-2020 season. Trophies will be awarded to the winners and runners up.
- (2) Entry is free. The draw for the first round will be made on 4 November 2019. All subsequent rounds will be drawn at management committee meetings or as otherwise agreed by the committee.
- (3) There are no restrictions on the composition of teams that clubs may enter other than all players must be registered for that club and have a current player membership with Table Tennis England. Once a player has played for one team in this competition he/she is cup tied and may not play for any other team in the current year's competition. Where a team concedes a match their club will incur a fine of an amount equivalent to the league guarantee fee. Additionally any team conceding a match must name their players on the result sheet. Those players will be cup tied and be unable to play for other teams in the club during the season's competition. If no players are named by the conceding team the competition secretary has discretion to allocate names based on league scorecards submitted for the season.
- (4) All players must have a grading to be eligible to represent their team in this competition. A list of gradings will be sent to each club and will also be available for viewing on the web sites of Cramlington TTC. (www.cramlingtontabletennis.info), Northumberland Table Tennis (www.cramlingtontabletennis.info), Northumberland Table Tennis (www.cramlingtontabletennis.info), Northumberland Table Tennis (www.cramlingtontabletennis.info), Northumberland Table Tennis (www.nctt.co.uk) and www.tabletennis365.com/northumbria. Any player who does not have a grading but has played a minimum of 4 matches in this season's league competition must apply to the Management Committee and may or may not be allocated a grading. Any handicap allocated on the limited information of 4 matches may, at the discretion of the Competition Secretary, be recalculated later in the competition based on subsequent results in the league.
- (5) The Club secretary will be notified by email of each match. It is the responsibility of the home team to arrange the match and the responsibility of the winning team to notify the Competition Secretary of the result by submitting the completed scorecard, preferably by email. The scorecard must be received, preferably by email, by the Competition Secretary by the date on the card and no later than 7 days after the match. Failure to do so could result in disqualification for both sides involved, unless, exceptionally, any prior arrangements have been made with the Competition Secretary.
- (6) Each match will consist of 9 singles only. Handicaps for each game will be based on the individual gradings of the players competing.
- (7) The responsibility for the correct calculation of handicaps lies with the 2 team captains and should be agreed before the match commences. Any errors discovered after the completion of the fixture will not be accepted as a reason for dispute.
- (8) The first round matches should be played during week commencing 4 November 2019 the second round in week commencing 2 December 2019, the third round in week commencing 27 January 2020 and the fourth round in week commencing 2 March 2020. All these weeks are free of league fixtures. Dates for subsequent rounds will be announced. Matches may be brought forward if convenient for the competing teams.
- (9) The semi-finals and final will be played at venues mutually agreeable to the competing teams.
- (10) Any dispute as to the interpretation of the regulations or any question arising not provided for herewith should be made in writing to the Competition Secretary and the decision of the Management Committee will be binding.
